In pursuance of the Judgment dated 13.09.2013 of the Hon'ble Supreme Court in WP (C) No.121 of 2008 – Resurgence India Vs Election Commission of India and others, regarding the filing of incomplete affidavit of candidates, the candidates are required to fill up all columns therein.
