In pursuance of the judgment dated 13.09.2013 of the Hon'ble Supreme Court in WP - C No 121 of 2008 -Resurgence India Election Commission Of India and other regarding the filing of incomplete affidavit of candidates, the candidates are required to fill up all columns therein.
