In Pursuance of the Judgment dated 13.09.2013 of the Hon'ble Supreme Court in WP C No 121 of 2008 -Resurgence India Election Commission Of India and other regarding the filing of incomplete affidavits of candidates, the candidates are required to fill up all columns therein.
