In pursuance of the judgement dated: 13.09.2013 of the Hon'ble Supreme Court in WP(C) No. 121 of 2008 Resurgence India VS Election Commission of India and other, regarding the filing of incomplete affidavit of candidates, the candidates are required to fill up all columns therein.
