BEFORE ME

the first time in the history of the world, the people of the United States have been called upon to determine whether they will submit to the law of force, or the law of the Constitution. We shall not shrink from that great responsibility.

It is now less than two months since the election of Abraham Lincoln as President of the United States. In that time, the Southern states have seceded from the Union, and the Federal troops have been driven from the capital city of Washington, D.C., and from the Federal fort at Sumter, in South Carolina. The Southern states have also passed ordinances of secession, and have established their own government, known as the Confederate States of America.

The Southern states have taken these actions in response to the election of Abraham Lincoln as President. They believe that Lincoln's policies, particularly his opposition to slavery, threaten the existence of the Southern states. They also believe that the Federal government has violated the Constitution by trying to interfere with their internal affairs.

The Northern states, on the other hand, believe that the Southern states have no right to secede from the Union. They believe that the Union is a permanent and unbreakable entity, and that the Southern states must return to it. They also believe that the Federal government has the right and duty to protect the rights of all citizens, regardless of their race or ethnicity.

The situation is now at a critical point. The Federal government has sent troops to defend the capital city of Washington, D.C., and to reinforce the Federal fort at Sumter. The Southern states have responded by sending their own troops to defend their territory. The conflict between the two sides is now open and unavoidable.

We must now decide what we will do. We must either support the Southern states and their right to secede, or we must support the Federal government and its right to maintain the Union.
