ORDER:

The Government have decided to declare Monday, the 5th August, 2019 as a Public Holiday for the areas comprised in 8.Vellore Parliamentary Constituency lying in Vellore District in connection with the General Election to 8.Vellore Parliamentary Constituency.

2. Accordingly, the following Notification will be published in an extra-ordinary issue of the Tamil Nadu Government Gazette dated: 23.07.2019.

Notification

Under the Explanation to Section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881), read with the Notification of the Government of India, Ministry of Home Affairs, No.20-25-26, Public-I dated the 8th June, 1957, the Governor of Tamil Nadu hereby declares Monday, the 5th August 2019, the date on which the poll for the General Election to 8.Vellore Parliamentary Constituency will take place, to be a public holiday for the areas comprised in the above Parliamentary Constituency lying in Vellore District.

(2) Further, all employees working in Vellore and the neighbouring Districts, but registered as voters in 8.Vellore Parliamentary Constituency, shall also be given a paid holiday on 05.08.2019.

(3) All Government offices including industrial establishments of the Government and Government controlled bodies and all the educational institutions throughout the area comprised in 8.Vellore Parliamentary Constituency lying in Vellore District will remain closed on 05.08.2019.
