Residents of low-income neighbourhoods flay delay in making corrections to electoral roll

Owing to inaccurately mentioned door numbers on the electoral roll, many residents did not get booth slips and were unable to vote in the Parliamentary elections in 2024; they have demanded special camps to carry out the corrections ahead of the Assembly elections in 2026

esidents in the low-income neighbourhoods that were redeveloped by the Tamil Nadu Urban Habitat Development Board (TNUHDB) have demanded special camps to carry out corrections related to door numbers on the electoral roll, ahead of the Assembly elections in 2026.

Owing to inaccurately mentioned door numbers on the electoral roll, many residents did not get booth slips and were unable to vote in the last Parliamentary elections in 2024.

Due to this, many such

neighbourhoods registered a low voter turnout.

But the Chennai District Election Office has not changed details about the door numbers even after the last elections.

Anna Nagar Ward 104 Councillor T.V. Shemmozhi said that the residents have demanded the Chennai District Election office to correct the door number of the houses mentioned on the electoral roll.

Reduced voter turnout

"During the Parliamentary elections, the voter turnout was around 35% at N.V.N. Nagar, after the houses were redeveloped. Before the redevelopment, When N.V.N. Nagar was redeveloped, the number of houses went up from 540 to 840, which caused difficulties for booth-level officers in tracing the houses

the voter turnout was around 65%," he said.

After the redevelopment of the area, the door numbers changed since the number of houses increased from 540 to 840, as the old houses on 11 streets were demolished for the construction of three blocks.

Residents from other

areas were resettled to this area.

As a result, the booth-level officers were not able to trace the correct door number. The distribution of booth slips also became a challenge.

'Facilitate the changes'

"The booth level officers and the booth level agents should facilitate the changes. Otherwise, the turnout will be poor in the Assembly elections in 2026," a resident said.

Meanwhile, Ward 84 Councillor J. John said that many voters who have shifted from the ward have their names on the electoral rolls.
