After AIADMK, BJP too boycotts East Erode bypoli

After principal opposition AIADMK's decision to boycott the Erode East bypoll, BJP has also followed suit, making the election victory a cakewalk for the ruling DMK.

BJP state president K Annamalai said on Sunday that their goal was only to win the 2026 assembly election.

The decision to boycott the bypoll was taken after consultations with NDA leaders in TN, he said. P6

BJP to boycott Erode East bypoll

Chennai: After the AIADMK, the BJP has also announced its decision to boycott the Erode East assembly bypoll scheduled for Feb 5.

BJP state president K Annamalai said in a statement on Sunday that the decision was made after detailed discussions with allied leaders. "Our goal is to defeat the DMK in the 2026 election and form the NDA govt," he stated.

The bypoll was necessitated by the death of E V K S Elangovan, the constituency's MLA, on December 14. The AIADMK and its ally DMDK had earlier cited concerns that the DMK would use 'undemocratic means' to win the poll. The BJP has cited similar reasons for its decision.

"DMK had violated all election rules in Erode East bypolls in 2023. People were locked in sheds and harassed. NDA does not want people to be locked in sheds like livestock again," Annamalai said.

Responding to the announcement, DMK general

secretary Duraimurugan said the boycott of opposition parties was a reflection of their strength in TN.

Former Telengana governor Tamilisai Sounderarajan
said it was not the election
that all parties are boycotting. "Rather, it's the DMK
that they are boycotting," she
told reporters. The parties
were forced to boycott the
election as they had no hope
of a fair election due to 'anarchy of DMK.'

AIADMK had boycotted the Vikravandi bypoll too held last year. However, NDA entered the fray, with BJP's ally PMK fielding their candidate since the constituency fell in Villupuram district, where the Vanniyar driven party has a strong base. However, DMK won the polls by a margin of more than 67,000 votes

Now, AIADMK and BJP have made the poll a cakewalk for DMK by boycotting the election. NTK will be the only major party to contest in the bypoll. NTK chief coordinator Seeman said he will announce his candidate for the bypoll on Tuesday.

Chennai: AIADMK organising secretary D Jayakumar has justified the party's deci-



sion to boythe cott Erode East bypoll saying it was to prevent "blatant electo-

ral rule violations by DMK".

Speaking to reporters in Chennai on Sunday, Jayakumar said there would be a repeat of 2023 Erode East bypoll in terms of "violations by DMK" if AIADMK en-tered the fray "DMK will distribute cash to all voters. They will give gifts to all houses in the constituency like how they did in 2023. They will lock people in sheds. We will complain to -ECI just like we did during the previous election. But, much like the past there will be no action this time too. So we want to avoid a repeat of this," Jayakumar said. "So there will be a mock-

ery of democracy and demonstration of money power resulting in unfair elections again," he said.

SC to hear Cong plea challenging amendments to election rules

NEW DELHI: The Supreme Court is slated to hear on Wednesday a plea filed by senior Congress leader Jairam Ramesh challenging the amendment to the Conduct of Election Rules, 1961, which restricts public access to election materials, such as CCTV footage unless explicitly listed by the Election Commission of India (ECI).

As per the causelist published on the website of the apex court, a Bench comprising CJI Sanjiv Khanna and Sanjay Kumar will take up the matter for hearing on January 15. In his plea filed on December 24 before the top court, the general secretary of the grand old party contended that the ECI cannot be

unilaterally amend the 1961 Conduct of Election Rules in such a brazen manner and without public consultation.

'A Writ has just been filed in the Supreme Court challenging the recent amendments to the Conduct of Election Rules; 1961. The Election Commission, a Constitubody, tional . charged with the conduct of free and fair elections cannot be allowed to unilaterally, and without

public consultation, amend such a vital law in such a brazen manner," said Ramesh, in a post on social media platform X.

Ramesh, Rajya Sabha MP, added that the amendment, introduced on December 21 following recommendations from the ECI, does away with "public access to essential information that makes the electoral process more transparent and accountable".

The integrity of the electoral process is fast eroding. Hopefully the Supreme Court will help restore it," he asserted.

directive to provide CCTV footage of an election booth. Earlier, Tamil Nadu Chief Minister MK Stalin strongly criticised the amendment and called it an undemocratic assault on free and fair elections.In a post on X, CM Stalin said that democracy was facing its gravest threat under the BJP-led Union Government. Voicing his objections, he said.

"Democracy is facing its gravest threat under the BJPled Union Government, with the reckless amendment of Section 93(2)(a) of the Conduct of Election Rules designed to undermine transparency in elections." CM Stalin added that the move undermines one of the Constitution's fundamental features - transparency.

The Tamil Nadu Chief Minister called on all political parties, including those aligned with the Union Government, to unite against what he termed an undemocratic assault on free and fair

elections.

BJP to boycott Erode (E) bypolls; strategic move, claims Annamalai.

CHENNAI: The State BJP unit on Sunday defended its decision to boycott Erode East bypoll, saying they want to stay away from electoral malpractices, alleging that previous by-elections were notorious for such violations.

"The DMK, in its lust for power, had confined voters in bars and subjected them to torture," State unit president Annamalai alleged, referring to the 2023 bypoll. "We will not allow the DMK to repeat this charade once again," he added. NDA's decision was a strategic move aimed at exposing the DMK's alleged misdeeds and targeted at mobilising public opinion against the ruling party, Annamalai claimed.

"Our goal is to remove the DMK from power in the 2026 Assembly elections and provide good governance to the people of the State. We are confident that the people will rally behind us and support our cause," he noted.

The decision was arrived at after a meeting with the BJP's national co-in-charge for Tamil Nadu, Ponguleti Sudhakar Reddy.

Elaborating on the decision, a top-level leader said, "Initially, our intention was to contest it as the Congress was supposed to be in the fray. However, given that the ruling DMK is now contesting directly, we anticipated that they will resort to extreme measures to inflate their vote margin. This compelled us to reassess our decision."

The insider said that they if the saffron party ends up with a negligible number of votes, it would have consequences in the Assembly polls. "After consultations we came to the decision," he said.

We relish battles, will declare candidate on Pongal day: Seeman .

(NTK) chief coordinator Seeman on Sunday said that his party will reveal the candidate's name for Erode East bypoll on January 14.

Speaking to reporters after celebrating Pongal with party workers at the NTK headquarters, Seeman said the party won't shy away from fighting the polls, unlike others, as it is a movement born out of struggles. "We (NTK) need to stand on the field and fight. We cannot afford to be absentee players in the democratic process. We will announce our candidate for Erode East bypoll on January 14 the Pongal day," Seeman said.

In contrast, he endorsed AIAD-MK general secretary Edappadi K Palaniswami's decision to boycott the bypoll, stating that the electoral process in the State has been compromised, regardless of the ruling

party. "By-elections are not being held democratically. This is not a recent phenomenon. It has been the case for a while now," he said.

Meanwhile, Seeman stood by his comments against Periyar EV Ramasamy, urging people to refrain from drawing parallels between Periyar and BR Ambedkar.

"Periyar's philosophy and legacy are unique and should not be compared with others. We are willing to engage in public debates and discussions on Periyar's ideology, but others seem hesitant to do so," he said.

Seeman slammed the ruling DMK party as "Karunanidhi's Property." He accused it of hiding behind Periyar's legacy. "The DMK is trying to conceal the sacrifices and struggles of thousands of Tamils who fought for the State's rights, language, and social justice. They are attempting to reduce the entire Tamil movement to a single figure, Periyar," Seeman alleged.

BJP eyes increased presence in T'gana Legislative Council

HYDERABAD: The Bharatiya Janata Party (BJP) is eyeing an increased presence in the Telangana Legislative Council as it announced candidates for three constituencies even before the announcement of the poll schedule by the Election Commission.

The saffron party took both the ruling Congress and the main opposition Bharat Rashtra Samithi (BRS) by surprise by declaring candidates for Medak-Nizamabad-Adilabad-Karimnagar Graduates' constituency, Warangal-Khammam-Nalgonda Teachers' constituency and Medak-Nizamabad-Adilabad-Karimnagar Teachers' constituency.

While the Medak-Nizamabad-Adilabad-Karimnagar Graduates' constituency is held by the Congress, the teachers' constituencies are represented by Independents

The BJP has named industrialist C Anji Reddy for the Medak-Nizamabad-Adilabad-Karimnagar Graduates' constituency, currently rep-

resented by senior Congress leader and former Minister T Jeevan Reddy.

The saffron party has decided to field educationist Malka Komaraiah for the Medak-Nizamabad-Adila-

bad-Karimnagar Teachers' constituency. Puli Sarottham Reddy will contest on a BJP ticket from Warangal-Khammam-Nalgonda Teachers' constituency. Sarottham Reddy, who hails from Warangal, served as a school teacher for more than 30 years.

He was general secretary of the Panchayat Raj Teachers' Union (PRTU) from 2012 to 2019 and was active during the statehood movement as part of the Teachers' Joint Action Committee.

The three MLC seats are going to fall vacant in March but the BJP named the candidates even before the announcement of the poll schedule to not only stump both Congress and BRS but also give ample time to the candidates to campaign.
